



## How CRPA Can Help Connecticut's Legislature

Our membership has deep and varied knowledge and expertise and is eager and willing to serve as resources to policymakers. As such, CRPA can provide professional input on a wide range of subjects, either in writing or through personal meetings and testimony.

## 2024 Legislative Goals

The Connecticut Recreation and Parks Association, Inc. (CRPA) is acutely aware of the fiscal challenges that our municipalities are facing. Inadequate funding affects our ability to serve the public. Affordable access to high quality recreation and parks services is essential to our ability to fulfill our mission. Consequently, we support the following public policy initiatives:

- CRPA stands ready to work with the Legislature and the Executive Branch to **continue to ensure safe access to our parks, trails and recreation opportunities**, all of which have proven to be **essential resources** to the **mental and physical wellbeing** of Connecticut residents throughout the COVID-19 pandemic and recovery.
- CRPA **cannot support** initiatives that would result in **increased costs** to park and recreation departments, therefore reducing access to **the high quality and affordable childcare programs** our departments offer. CRPA **supports** initiatives that **increase access** to these essential programs.
- CRPA supports actions that **promote healthy lifestyles, work to combat obesity**, raise awareness to the **dangers of drug and opioid use**, maintain family friendly spaces, and **enhance childhood development** through play and education.
- CRPA supports initiatives that **sustain affordable access** to park facilities and recreational programs. CRPA **cannot support mandates that increase costs**, such as implementing predictive scheduling. Such unfunded mandates **reduce our ability** to provide opportunities for full-time and seasonal employees and those with disabilities, and reduce affordable program access to members of our communities.
- CRPA opposes state mandates that limit municipalities' ability to safely operate their own natural resources and recreational facilities.
- CRPA believes that **timely and affordable background checks** on employees and volunteers who work with vulnerable populations such as children and the elderly are essential to public safety.
- CRPA supports **preservation of funding** to the maximum extent possible to municipalities for such programs as: DEEP's CT Recreational Trails Grant, Rails to Trails, LWCF State Assistance Program, Local Capital Improvement Funds (LOCIP), 319 watershed grants, etc.
- The State's current law on pesticide management is unworkable. It neither adequately protects the public nor allows for **safe and efficient management of public fields & grounds**. CRPA supports the amendment of statutes and regulations that control the application of synthetic and organic substances on public playing fields that is based on science, education and training, and research.
- CRPA **supports** the use of **artificial products** for both **playground and athletic surfacing**, especially as a means for providing inclusive access. CRPA members strive to utilize the safest materials possible and feel that any legislation banning such products should be consistent with **science, education, and research**.
- CRPA supports the need for **education and awareness** and commits to working with policymakers to create **effective and manageable guidelines** that address the **safety of youth athletes**, while at the same time **limiting the liability** to both the municipality and its volunteers and staff.
- CRPA members provide a wide range of programs and services to their communities, including **vulnerable populations** therefore, CRPA **supports initiatives** (i.e. water safety awareness) that **protect the safety, health, and wellbeing of participants, volunteers, and staff**.
